A RESOLUTION TO PROCEED AND SUBMIT THE QUESTION OF LEVYING A TAX OUTSIDE THE TEN-MILL LIMITATION FOR CONTINUING FIRE AND EMERGENCY MEDICAL SERVICES IN ALLEN TOWNSHIP, UNION COUNTY OHIO, AND DIRECTING THE FISCAL OFFICER TO CERTIFY AND TO FILE THE NECESSARY DOCUMENTS WITH THE BOARD OF ELECTIONS.

The Board of Township Trustees, Allen Township, Union County, Ohio, met in special session on January 19, 2022, at the Allen Township Hall, 16945 Allen Center Road, Marysville, Ohio, Allen Township, 43040, with these members present: Don McCreary, Ricky Kingham, and Jack Rausch.

Trustee Kingham introduced this resolution and moved its passage:

**WHEREAS**, on January 3, 2022, the Allen Township Board of Township Trustees passed a resolution declaring the necessity, for the purpose of Fire and Emergency Medical Services, to levy a tax in excess of the ten-mill limitation under R.C. §5705.19(I) at the rate of six (6) mills or nine (9) mills for each one dollar of valuation, which amounts to six cents (\$0.60) or nine cents (\$0.90) for each one hundred dollars of valuation, for a continuing period of years; and

**WHEREAS**, on January 5, 2022 the Union County Auditor has certified to the Allen Township Board of Township Trustees that the dollar amount of revenue that would be generated by the tax levy during the first year of collection at the rate of six (6) mills is Seven Hundred Eighty-Nine Thousand, Forty-One Dollars (\$789,041.00), based on the current assessed valuation of the Township of One Hundred Thirty-Eight Million, Four Hundred Twenty-Eight Thousand, Two Hundred-Ten Dollars (\$138,428,210.00); and

**Whereas**, on January 5, 2022 the Union County Auditor has certified to the Allen Township Board of Township Trustees that the dollar amount of revenue that would be generated by the tax levy during the first year of collection at the rate of eight (8) mills is One Million, Fifty-Two Thousand, Fifty-Five Dollars (\$1,052,055.00), based on the current assessed valuation of the Township of One Hundred Thirty-Eight Million, Four Hundred Twenty-Eight Thousand, Two Hundred-Ten Dollars (\$138,428,210.00)

THEREFORE, BE IT RESOLVED BY THE ALLENTOWNSHIP BOARD OF TOWNSHIP TRUSTEES, UNION COUNTY, OHIO, THAT:

The board of trustees, two-thirds of all members elected thereto concurring, that the board desires to proceed with submitting the question of an additional tax levy for the purpose of providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of fire-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company, or for the payment of other related costs under R.C. §5705.19(I) at the rate of six (6) mills for each one dollar of valuation, which amounts to sixty cents (\$0.60) for each one hundred dollars of valuation, to the electors of Allen Township.

**RESOLVED**, that the tax levy will be for a continuing period of years and such levy will include a levy on the current year's tax list, beginning in 2022, first due in calendar year 2023, if approved by a majority of the electors voting on the question.

**RESOLVED**, the question of such tax levy shall be submitted to the electors of Allen Township at the election to be held therein on May 3, 2022.

**RESOLVED**, that on or before February 1, 2022 the Fiscal Officer is hereby directed to certify to the board of elections, Union County, Ohio, a copy of the Resolution of Necessity, a copy the certification of Estimated Revenue by the Union County Auditor, and a copy of this Resolution to Proceed, to notify the Board of Elections to cause notice of election on the question of levying the tax to be given as required by law.

**RESOLVED**, that it is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were passed in an open meeting of this Board, and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements including Revised Code §121.22.

Trustee McCreary seconded the motion, after discussion, the roll was called on the question of its adoption. The vote was:


